- Possesses a pioneering spirit and has achieved success despite challenges attendant to new endeavors.
- Committed to the promotion of the well-being and upliftment of the people and community she serves.
- Willing to serve as a TOWNS member and do volunteer work in any of the TOWNS projects for at least three years after her award
